

COCA REPORT:

Due to the election call, almost all government legislative committees have come to a halt. Progress on initiatives for Prompt Payment, which had all Party agreement, did not make it to third reading for adoption. With agreement from all Parties in the new Legislature the Prompt Payment may be reintroduced for passage into law. Don't hold your breath, as these things seem to take on life of their own. The Annual COCA kickoff for the Construction Season at Queen's Park was cancelled once the election date was set. The "House" is now empty of MPPs, so there was little point in the very successful annual COCA event taking place.

The Ontario College of Trades is still very much top of mind with many construction Associations represented at COCA. concerns expressed by many, including that of COCA Chair, Mr. Don Gosen, who in on the OCOT Board, and others, have caused the College to put a hold on the process of determining the application for Mandatory Trade status. The application for making carpenters a *mandatory trade* was very controversial. The for this process determination was seen as being unrepresentative of the construction industry's best interests.

The good news from the WSIB is that the there is a surplus this past year. There now is a discussion going on within the WSIB as to what to do with this surplus? The options considered by some in the industry include passing on a slight reduction in rates, or adding new benefits for claims, or to use the

surplus to pay down the huge unfunded liability.

It should be noted that the present objective is to pay off the UL by 2027. By using the surplus revenues to pay down the debt would make it possible to pay the debt sooner. The WSIB is going through a serious review of its methodology about rates, benefits, and operations. On another matter, there is some concern that the Board of the WSIB continue be by professional insurance to run professionals. This Board is responsible to create policies that generate benefits for its members based on sound insurance based long term sustainability. The appointment recently of a political person, without solid professional credentials in the accounting or insurance industries, may be a forecaster of things to come. WSIB is changing and is showing signs that good management can create successful outcomes. There is a long way to go, but now is not the time to use board positions as political rewards.

Design and Construction of Agricultural Buildings An Engineers Perspective

INTRODUCTION:

Tacoma has been providing Ontario with structural consulting services since 1980. Tacoma has been involved in the agricultural sector for over 30 years, and has proudly participated in the evolution of farm structures. The CFBA, (Canadian Farm Builders Association) have also been involved in the agricultural sector. This organization is a group of builders, suppliers, consultants, building officials and other affiliate members who share a passion for farm buildings and promoting the agricultural sector.

NATIONAL FARM BUILDING CODE:

Canadian Commission on Building and Fire Codes published the NFBC in 1995 as a National Model Code. The NFBC provides accommodations with respect to design loads, building materials, means of egress, building separation and size and exterior access. There has been a Task Force established to update the NFBC. The codes have not kept up with the requirements of the farming industry. But there is a big concern from the western provinces that the Provinces will lose confidence with the existing 1995 national model code.



Ontario Association of Fire Chiefs states that the NFBC may not adequately address the fire safety risks. Publication 837 examines the major causes of farm building fires and what can be done to reduce the risks. Some of the factors found were: Building Access and Water Supply; Combustible Material, Spatial Separation, Appliances, and Unrestricted Fire Spread.



COLLAPSE INVESTIGATIONS:

Most collapses are linked to the issues of

- Inadequate bracing during construction.
- Inadequate permanent bracing.
- Natural causes (wind, snow, etc.)
- Long term deterioration
- Construction shortcuts

SLOW MOVING VEHICLES

As winter draws to a close, we need to pay attention to the signs of spring – SMV (Slow Moving Vehicle) sign that is. These days, more and more farmers are active in multiple locations and the need to move equipment on the roadways is becoming increasingly necessary for the job. However, the key to your safety on roadways is to be seen by other motorists. The SMV sign can help make other drivers aware of you and is also a legal requirement in Ontario.

Farm tractors and/or self-propelled implements must display a sign on the rearmost part of the vehicle whenever travelling on roadways. If one of these machines is towing one or more implements of husbandry, the sign or an additional sign, must be displayed on the rear of the entire vehicle combination.

BUGGIES ARE VEHICLES TOO

Every year there are too many reported collisions between motorists and horse-drawn buggies on Ontario's roadways in communities where horse-drawn vehicles are a mode of transportation.

When horses and cars collide, the horse is often the biggest thing in the equation. They're temperamental and have their own dispositions – a horse is not a perfectly predictable machine. A horse drawn vehicle deserves to be treated like any other vehicle on the road.

WORKING AT HEIGHTS ADVISORY MESSAGE FROM ONTARIO'S CHIEF PREVENTION OFFICER

Working at heights in construction, at this time of year, can be dangerous. A small slip can lead to serious consequences. Falls are the number one cause of tragedies at Ontario construction sites. By law, employers must ensure workers are protected when working at heights. This summer, Ministry of Labour inspectors will target hazards falls province-wide involving during а construction blitz. And, on July 1, mandatory health and safety awareness training will go into effect for workers and supervisors.

<u>Prevention is the key to worker safety when working at heights.</u>

Here are some questions to ask yourself before you start work:

- Do you understand the hazards?
- Have you been properly trained?
- Are rescue procedures in place?
- Will work be performed on ladders?
- Do you have proper fall protection equipment?

We all need to get the message out to employers, workers, educators, parents, and students working summer jobs.

Tragically, in 2013, 17 workers died and 134 workers received critical injuries in construction site incidents. More than half of those deaths and injuries were due to falls.

relaxed and improves milk yields." The cows are partial to the tunes "She's a Lady and Delilah". There are even pictures of the legendary Welshman hanging up in the barn. Steve Ledsham, and English chicken farmer, to the Daily Mail he discovered his chickens' appreciation for the music of Andrew Lloyd Webber when egg production doubled after he had been playing the tunes while building a barn near the coop. Now he makes sure music is always playing for his hens. The practice is fairly popular. A 2012 Freedom Food survey of British farmers found 44 per cent play music for their animals or keep the radio on for them. The key, it seems, is a constant rhythm that can drown out stressful background noises from machinery or at feeding time.

Day Of Mourning

Consultation On Occupational Exposure Limits

The ministry has begun consultation on proposed new occupational exposure limits (OELs) for a number of hazardous substances regulated under the Occupational Health and Safety Act. This year, in addition to proposing new OELs, the ministry is proposing two initiatives to expedite the process of adopting more protective OELs.



Workplace rights campaign targets vulnerable workers

The month-long "Know Your Workplace Rights" campaign, featured advertisements in 27 languages from Arabic to Vietnamese – and reached TV, digital media and ethnic print publications. The campaign sought to raise awareness of workers' rights to be treated fairly on the job, work in a safe and healthy workplace, and to be trained to handle workplace hazards.

The campaign is part of the Ontario government's ongoing commitment to protect vulnerable workers, immigrants, new Canadians who speak neither English nor French, migrant workers and foreign live-in caregivers.



Health and safety training for workers and supervisors becomes mandatory on Canada Day

The Ministry of Labour wants to remind workplaces that mandatory health and safety training for workers and supervisors comes into force July 1, 2014.

This means that workers and supervisors at workplaces that fall under the Occupational Health and Safety Act need to be trained in basic health and safety awareness by that date.
